This Just In...

City Council recap April 16, 2018

#### **Public comments:**

**Karen Zyczynski** represented the AAUW\* of Northville/Novi Chapter. She provided an overview of the organization that advances equity for women and girls through advocacy, education, philanthropy and research. She thanked the City Council for issuing a proclamation that recognized April 10, 2018 as Equal Pay Day. That's the

date that women's pay equals men's for the same job. On average, she noted, a white woman's pay rate is 78¢ for every \$1 a white man earns. It's even less for minority women. (\*AAUW is the American Association of University Women.)

**Dr. Ghulam Qadir**, a psychiatrist and the CEO of a mental health practice in Dearborn, introduced himself as a candidate for the state senate. He resides in Northville Township and noted that building and maintaining good quality roads is a top priority.

Report from Financial advisers - Jaymes Vettraino, of Vettraino Consulting, and John Kaczor, of Municipal Analytics, presented their final report on a review of the City's long-range financial plan, with a close look at infrastructure costs, pension funding, and expenditures and liabilities. To fund road improvements, the advisers recommended securing a \$3.2 million bond (@ 3.5%) with funds generated by a .97 millage. If City Council approves a millage request, it will be placed on the November 2018 ballot.

**Zoning section:** Six ordinance amendments were presented for either first reading or second reading and approval. They are:

- 1. Special Land use in general commercial district (Section 11.03) First reading: Eliminate the phrase "no more obnoxious or detrimental to the surrounding area" because it is vague. The Planning Commission instead is advised to use the Special Land Use standards to gauge whether an unlisted proposed use is similar to other acceptable uses in the district in question.
- 2. **Special Land Use Standards (16.01)** First reading: The recipient of applications and materials for special land use requests will be designated as the Building Department rather than the City Clerk.
- 3. **Fences** (Section 18.09) First reading: If a residential property backs on a heavily traveled road, e.g. Beck, Novi Road, 8 Mile, etc., a fence no higher than 6 feet can be erected in the back yard or a side yard that faces the busy street.
- 4. Site condominium development standards (Section 18.14) First reading: An applicant must submit "draft" condominium documents to the City Attorney for review after the Preliminary Site Plan has been approved. Any draft documents not approved by the City attorney must be brought back to the Planning Commission, which may recommend changes prior to final acceptance. The previous language required that the condominium documents be finalized at the review stage by the City attorney.
- 5. Senior Living Facilities (section 16.18) First reading: A senior living group residence can only be built in the zoned multi-family district, R-3 or R-4, not on Cady Street or in the downtown area. The language was revised to reflect the current definitions of senior housing, ranging from independent apartments to Continuing Care Retirement Communities. The amendment also adds standards for site development and parking.
- 6. **Master plan changes involving Cady St. and Foundry Flask** Second reading/approval by City Council: The amendment, in part, permits some first floor residential and removes some density requirements (number of units per

acre). It now goes to adjourning communities for a 42-day review, then will be discussed at a public hearing. Any revisions based on those reviews will be made by the Planning Commission before it is presented in final form to City Council.

**Parking decks** - City Council approved a contract, submitted as part of a bid process, to Carl Walker/WGI of Kalamazoo, in the amount of \$15,750 to prepare an evaluation, rehabilitation and maintenance plan for the MainCentre and Cady Street parking decks.

# Oakland County Health Division reports confirmed rabies in skunk

A confirmed case of rabies has been found in a skunk removed from Rochester Hills. The Oakland County Health Division strongly urges residents to reduce rabies exposure by staying away from wild animals such as skunks, bats, raccoons, foxes, and stray cats and dogs.

If a wild animal is found behaving strangely, call the Oakland County Animal Shelter and Pet Adoption Center at 248-391-4102 for assistance. If bitten by any wild animal or an animal unknown to you, wash the affected area thoroughly with soap and water and seek medical attention immediately. To report an animal bite, call the Health Division at 248-858-1286.

The rabies virus is found in the saliva of infected animals and is spread through bites or scratches. There are simple steps everyone can take to protect themselves from rabies:

Have pets vaccinated regularly. This will protect them if exposed to animals

with the disease and prevent them from becoming a carrier and infecting humans.

- Do not handle stray, wild or dead animals.
- Call local animal control experts for help if an animal is acting strangely, including: having problems swallowing, exhibiting lots of drool or saliva, appearing tamer than you would expect, biting at everything, and/or having trouble moving or is paralyzed.
- Keep pets indoors or supervised to limit their exposure to wild animals that may be rabid.
- Use a leash when walking dogs or keep them in a fenced-in yard.
- Do not feed or put water for pets outside.
- Keep garbage securely covered, as these items may attract wild or stray animals.

# Oakland County offering free Financial Education Seminars during National Money Smart Week April 21-28



# Northville Historical Society 2018 Lecture Series The Wreck of the Edmund Fitzgerald April 25, 2018

The Edmund Fitzgerald is the largest shipwreck in the Great Lakes, broken into pieces by a November gale in 1975. 29 men simply vanished in the storm, leading researchers to puzzle over the final moments that denied the sailors a Mayday call.

Rie Mixter has visited the wreck site in person, diving 550 feet down in a small submersible in 1994. Since that time, he has interviewed investigators from the Coast Guard and Cousteau Society as well as the men who built the Fitz in Detroit. His documentary is considered the best available on the subject with exclusive construction footage Mixter uncovered as well as his spellbinding video from down below.

Rie Mixter was given an award for 20 years of maritime preservation by the Association of Great Lakes Maritime History. He has produced over 30 shows on local history for PBS and the Outdoor Channel and has appeared on the History and Discovery Channel as a shipwreck expert. Energetic and animated, he has changed the way lecturers share history.

The lecture will be at the New School Church at Mill Race Historical Village, 215 Griswold St, Northville at 7:00pm. The lecture is free of charge although donations are accepted at the door to help defray costs.


Items accepted: Household paints, stains, dyes; floor wax, carpet cleaner; furniture polish, bathroom cleaners, stain removers, solvents; pharmaceutical waste (non-controlled substances only); nail polish, glue; fertilizer, lawn and garden chemicals, pesticides; antifreeze, motor oil, gasoline; automotive batteries and dry cell batteries, fluorescent bulbs (all types); fire extinguishers and smoke detectors; mercury thermometers, thermostats and elemental mercury.

Electronics Recycling - computer CPU's, monitors, printers, scanners, keyboards, mice; cell phones, fax machines, copiers and televisions.

#### Items not accepted

Commercial waste, industrial waste, radioactive material, explosives, ammunition, 55-gallon drums, shock sensitive materials, household trash, refrigerators, microwaves or other appliances, tires, yard waste and concrete. # Streetlights

Streetlight out? Businesses and residents can <u>report streetlight outages online</u>. This link goes directly to the DTE streetlight outage reporting tool.

Businesses and residents who have a DTE wooden power pole on or adjacent to their property are eligible to have outdoor protective lighting installed on the pole to illuminate their private property. Residents may even qualify for no up-front cos installation. Please call 866-503-0627 and leave a detailed message that includes name, address, city, zip code and phone number with area code for a DTE representative to contact you within 3 business days.

# Brush collection program

The City of Northville allows residents to place branches at the curb without bundling or bagging them. Branches 6 feet long and up to 6 inches in diameter can be placed at the curb for removal by the City's solid waste collection contractor.

Residents can dispose of large piles of branches by placing them at the curb. *Every Tuesday, year-round*, a crew will come through each neighborhood and chip any branches left at the curb.

Branches must be in the street right-of-way (Between the street and the sidewalk). Simply stack the branches neatly behind the curb with the cut ends facing the street.

The following items are not collected: roots, stumps dirt, lumber, railroad ties or wood with metal in it.

Residents can dispose of firewood pieces and stumps with their normal weekly garbage (Maximum 35 gallon cans and 60 lb. weight limit).

Collection crews will not rake up small branches after the large brush piles are removed. Residents may have to rake these areas after bulk brush collection has been made.

# Sewage backups

Homeowners may experience an overflow or backup of a sewage disposal system or storm water system. If you intend to file a claim with the City, <u>please check our website for details</u> or call the Department of Public Works at 248-449-9930.

When presenting a written claim, you will be required to provide the following items:

- 1. Copies of receipts for cleaning costs, plumbing bills or other bills.
- List of the damaged items and receipts to prove the ages of your items.Reimbursement for the actual cash value of damaged items is the maximum amount payable.
- 3. Please make an attempt to provide pictures of anything you wish to claim that was damaged due to the sewer backup.

The filing of a claim does not guarantee reimbursement.

Most homeowner's insurance will not cover sewage backups, but insurance can often be obtained as an added item. Ask your insurance provider about this option. Also, consider having a plumber install a check valve - backflow preventer - to help
